#### PRESENTATION OF FINANCIAL AND OTHER INFORMATION

#### Financial information and operational data

Unless otherwise indicated, all financial information in this report has been prepared in accordance with IFRS applicable at the relevant date and is presented in Euros. IFRS differs in certain significant respects from generally accepted accounting principles in the US.

We have presented certain information in this report that has not been prepared in accordance with IFRS or any other accounting standards. As used in this report, this information includes "EBITDA", which represents operating profit before amortization, impairment and depreciation. This report also contains other measures such as: cash, cash equivalent and current financial assets, total financial debt and net financial debt. We present these non-IFRS measures because we believe that they and similar measures are widely used by certain investors, securities analysts and other interested parties as supplemental measures of performance and liquidity.

In particular, we believe that EBITDA is meaningful for investors because it provides an analysis of our operating results, profitability and ability to service debt and because EBITDA is used by our chief operating decision makers to track our business evolution, establish operational and strategic targets and make important business decisions. To facilitate the analysis of our operating profit in order to eliminate the impact of general long-term capital investment. Although we are presenting this measure to enhance the understanding of our historical operating performance, EBITDA should not be considered an alternative to operating profit as an indicator of our operating performance, or an alternative to cash flows from operating activities as a measure of our liquidity. The presentation of these measures is not intended to and does not comply with the reporting requirements of the SEC; compliance with its requirements would require us to make changes to the presentation of this information.

Rounding adjustments have been made in calculating some of the financial information included in this report. Figures shown as totals in some tables and elsewhere may not be exact arithmetic aggregations of the figures that precede them.

We have obtained this information from various third party sources, including providers of industry data, discussions with our customers and our own internal estimates. In particular, we have initiated exploratory activities with respect to a potential initial public offering of our share capital. There can be no assurance that we will pursue any such strategic alternatives, including any initial public offering.

## Third quarter of 2016 compared to third quarter of 2015

## Revenue

Revenue increased by  $\notin$  21.9 million, or 1.4%, to  $\notin$  1,615.8 million in the third quarter of 2016 compared to sales of  $\notin$  1,593.9 million in the third quarter of 2015. The increase in revenue is attributable primarily to sales increases of  $\notin$  20.6 in Asia,  $\notin$  17.3 million in South America,  $\notin$  10.9 million in Eastern Europe and  $\notin$  4.3 million in North America, offset in part by a sales decrease in Western Europe of  $\notin$  31.2 million.

<u>Body-in-White and Chassis</u>. Revenue decreased by  $\in$  12.3 million, or 0.9%, to  $\in$  1,337.7 million in the third quarter of 2016 from  $\in$  1,350.0 million in the third quarter of 2015. This decrease was attributable primarily to decreases of sales in South America of  $\in$  15.0 million (Argentina) and Western Europe of  $\in$  13.5 million (mainly in France and United Kingdom), offset by an increase of sales in North America of  $\in$  10.0 million, in Eastern Europe of  $\in$  5.3 million and in Asia of  $\in$  0.9 million.

<u>Mechanisms</u>. Revenue increased by  $\notin$  39.2 million, or 22.0%, to  $\notin$  217.0 million in the third quarter of 2016 from  $\notin$  177.8 million in the third quarter of 2015. This increase was attributable primarily to an increase of sales in Brazil, China, Czech Republic, Germany, South Korea and Spain.

<u>Tooling and Other</u>. Revenue decreased by € 5.0 million, or 7.6%, to € 61.1 million in the third quarter of 2016 from € 66.1 million in the third quarter of 2015. This decrease was attributable primarily to a decrease in sales in Western Europe by € 23.4 million and in North America by €7.4 million, mitigated by an increase in South America by € 16.6 million, Eastern Europe by €4.9 million and in Asia by € 4.3 million.

# **Operating expenses**

<u>Raw materials and other consumables</u>. Expenses on raw materials and other consumables decreased by  $\notin$  95.5 million, or 9.7%, to  $\notin$  888.9 million in the third quarter of 2016 from  $\notin$  984.4 million in the third quarter of 2015. The decrease in raw materials and other consumables expenses in the third quarter of 2016 is mainly due to lower volume of subcontracted work to third parties.

<u>Personnel Expenses</u>. Personnel expenses increased by  $\notin$  23.9 million, or 7.9%, to  $\notin$  327.6 million in the third quarter of 2016 from  $\notin$  303.7 million in the third quarter of 2015, mainly in South America, North America and Eastern Europe and, consistent with the respective increases in sales.

<u>Depreciation, amortization and impairment losses</u>. Depreciation expense increased by  $\notin$  0.8 million, or 0.9%, to  $\notin$  89.1 million in the third quarter of 2016 from  $\notin$  88.3 million in the third quarter of 2015.

<u>Other operating expenses</u>. Other operating expenses increased by € 29.2 million, or 14.8%, to €226.8 million in the third quarter of 2016 from € 197.6 million in the third quarter of 2015, mainly in North America. This increase was primarily due to higher maintenance and leasing expenses.

## Operating profit or loss

Operating profit increased by  $\notin$  15.6 million, or 21.4%, to  $\notin$  88.5 million in the third quarter of 2016 from  $\notin$  72.9 million in the third quarter of 2015. This increase is primarily due to a lower consumption of raw materials and other consumables in 2016 compared to the third quarter in 2015.

# EBITDA

EBITDA increased by  $\leq$  16.4 million, or 10.2%, to  $\leq$  177.6 million in the third quarter of 2016 from  $\leq$  161.2 million in the third quarter of 2015. This increase is primarily attributable to the lower volume of operating expense in the third quarter of 2016 compared to the third quarter of 2015.

# Net financial income (expenses)

Net financial expenses decreased by  $\notin$  6.1 million, or 23.4%, to  $\notin$  20.0 million in the third quarter of 2016 from  $\notin$  26.1 million in the third quarter of 2015. This decrease is primarily due to lower average interest rates and the renegotiation of loan interest margins with financial entities.

# Exchange gains (losses)

In the third quarter of 2016, there were exchange losses of  $\in$  5.9 million while in the third quarter of 2015 there were exchange losses of  $\in$  44.6 million. The exchange losses in the third quarter of 2016 were primarily due to the depreciation of the Pound Sterling against the Euro during the quarter.

# Income tax

Income tax expense increased by € 5.9 million, to € 16.0 million during the third quarter of 2016 from € 10.1 million during the third quarter of 2015. This increase is primarily due to higher results obtained in countries with higher tax rates such as South America and North America.

# Profit attributable to non-controlling interests

Profit attributable to non-controlling interests increased by  $\in$  21.0 million to  $\in$  8.4 million in the third quarter of 2016 from  $\notin$  -12.6 million in the third quarter of 2015, largely as a result of higher results in operations with minority partners.

#### Cash flow from operating activities

Cash flow from operating activities decreased by  $\notin$  96.2 million to a net amount of  $\notin$  17.0 million during the third quarter of 2016 from a net amount  $\notin$  113.2 million in the third quarter of 2015, primarily due to an increase in the cash used for working capital.

#### Cash flow from (used in) investing activities

Cash flow used in investing activities increased by € 172.8 million in the third quarter of 2016 to € 242.1 million from € 69.3 million during the third quarter of 2015. The cash flow used in the third quarter of 2016 was primarily for investments in projects in North America, Poland, China, Germany, Spain and the United Kingdom.

#### Cash flow from (used in) financing activities

Cash flow from financing activities amounted to € 143.4 million during the third quarter of 2016 primarily due to a net increase in interest-bearing loans and borrowings and use of credit lines.

# Liquidity

Our principal source of liquidity is our operating cash flow, which is analyzed above. Our ability to generate cash from our operations depends on our future operating performance, which is in turn dependent, to some extent, on general economic, financial, competitive, market, regulatory and other factors, many of which are beyond our control.

Our long-term indebtedness primarily consists of € 471.9 million Euros in senior secured notes; € 832.9 million in long-term portion of a funded senior secured amortizing Term Loan (part of the Senior Financing Agreement, or "SFA", originally syndicated on April 19, 2013, of which an additional € 280 million is in the form of a Revolving Credit Facility), € 160.0 million in long term debt with the European Investment Bank and € 112.6 million of aggregate principal amount in other long-term financing.

On May 11, 2016 we issued € 500 million of new senior secured notes due May 15, 2023 and on May 20, 2016 we signed an amendment and restatement of our SFA according to which, among other things, we agreed an increase in the availability of the Term Loan component of the SFA by € 340 million and extended the maturity of the Term Loans and the RCF to May 31, 2021. On June 6 and June 20, 2016 respectively we fully redeemed the remaining outstanding Euro and USD senior secured notes due May 2020 with proceeds from the aforementioned new senior secured notes and the increase in the SFA.

Although we believe that our expected cash flows from operations, together with available borrowings and cash on hand, will be adequate to meet our anticipated liquidity and debt service needs, we cannot assure you that our business will generate sufficient cash flows from operations or that future debt and equity financing will be available to us in an amount sufficient to enable us to pay our debts when due, including the notes, or to fund our other liquidity needs.

We believe that the potential risks to our liquidity include:

- a reduction in operating cash flows due to a lowering of operating profit from our operations, which could be caused by a downturn in our performance or in the industry as a whole;
- the failure or delay of our customers to make payments due to us;
- a failure to maintain low working capital requirements; and
- the need to fund expansion and other development capital expenditures.

If our future cash flows from operations and other capital resources (including borrowings under our current or any future credit facilities) are insufficient to pay our obligations as they mature or to fund our liquidity needs, we may be forced to:

- reduce or delay our business activities and capital expenditures;
- sell our assets; or
- obtain additional debt or equity financing.

As market conditions warrant, we may from time to time purchase, redeem, repurchase, prepay, cancel or otherwise restructure or refinance all or a portion of our indebtedness including debt under the notes and the Senior Facilities, in privately negotiated transactions, open market transactions or otherwise. We cannot assure you that we would be able to accomplish any of these alternatives on a timely basis or on satisfactory terms, if at all. In addition, the terms of the notes and any future debt may limit our ability to pursue any of these alternatives.

We are leveraged and have debt service obligations. We anticipate that our leverage will continue for the foreseeable future. Our level of debt may have important negative consequences for you.

#### Working capital

Our working capital requirements largely arise from our trade and other receivables, which are primarily composed of amounts owed to us by our customers, inventories primarily composed of raw materials (mainly steel) and other current assets which comprise receivables accounts with the public treasury by the advanced payments of taxes or refunds of taxes. Our trade and other payables primarily relate to trade payables to our suppliers for raw materials and services, other amounts to the public treasury for taxes and payments to our employees by way of salaries. We have historically funded our working capital requirements through funds generated from our operations, from borrowings under bank facilities and through funds from other financing sources.

Net working capital requirements increased by  $\notin$  66.8 million during the third quarter of 2016, due primarily to an increase in the amount of receivables related to customer tooling that increased during the quarter by  $\notin$  77.2 million, while the average days for collections from customers and the average days for payments to suppliers were at similar levels with respect to the second quarter of 2016.

Net working capital requirements decreased by  $\in$  0.5 million during the third quarter of 2015. The average days for payment to suppliers in the third quarter of 2015 decreased by 10 days with respect to the second quarter of 2015; and the average days for collections from customers in the third quarter of 2015 decreased by 10 days with respect to the second quarter of 2015.

Investments in fixed assets during the third quarter of 2015 and 2016 amounted to approximately  $\notin$  128.0 million and  $\notin$  165.3 million, respectively. Investments in fixed assets primarily consists of expenditure on property, plant and equipment. This includes expenditure on new manufacturing plants and expansion of existing plant capacity for new production lines, maintenance capital expenditure comprised of expenditures on maintenance of machinery and buildings, improvements of existing plants driven by health and safety and noise reduction concerns and replacement capital expenditure incurred in relation to changes to our production platforms in connection with new models. Replacement capital expenditure is primarily incurred in connection with updating our welding and assembly cells and equipment, given that the most costly categories of our infrastructure, such as land, buildings and press equipment, have long lives and can be adapted with relatively low expenditure for replacement or renewal business.

Investments in fixed assets also includes expenditure on intangible assets, such as research and development costs.

Net payments on investments reflect actual cash outlays for fixed assets, taking into account increases and decreases in payables to our suppliers of fixed assets, as well as proceeds from divestments of fixed assets, and amounted to approximately € 139.8 million and € 186.7 million during the third quarter of 2015 and 2016 respectively.

## **Contractual obligations**

We have contractual commitments providing for payments primarily pursuant to our outstanding financial debt, including the financial obligations arising from the senior secured notes but excluding financial derivatives.
